Dura Cycles Bicycle Rental Agreement and Policy

I hereby acknowledge and agree to the following rental agreement terms and conditions:

- Bicycles are rented out clean and in proper working condition and must be returned in the same manner.
- Helmets are included in the rental, and are required to be worn at all times while riding bicycles rented from Dura Cycles. If a customer is seen to be riding a Dura Cycles rental bicycle without a helmet, they will be expected to return the bicycle immediately with no refund.
- Bikes are maintained on a daily basis. It is the responsibility of the client to check the bike at the store BEFORE setting out on any ride.

I, the customer, agree to return the bicycle in a clean, undamaged condition to avoid any additional charges for repair, maintenance or replacement. I, the customer, accept use of the equipment, as is, in good condition and accept full responsibility for care of the equipment while under my possession. Damaged parts or components will be repaired or replaced at the shop, Dura Cycles discretion and I, the customer, agree to pay regular shop rates and retail prices for the components replaced. Clean condition means normal wear and tear is accepted but does not include broken spokes, rims, bent rims, damaged frames, handlebars, seat and other parts from misuse and/or crashes.

Note: All bicycles should be returned clean of mud and debris. Any bike not returned clean will be assessed a 1 hour additional fee. Hourly or daily rentals are due back 15 minutes before closing time. Late returns are subject to fees.

The customer, agrees to provide Dura Cycles with his/her credit card details and copy of identity, for precautionary use only.

I _____, authorize Dura Cycles to charge the credit card they have on file for me for all eventual costs in case of damages to the bicycle(s) during my rental period, comprehensive of labour, except in the case that I can demonstrate other's faults with evidence and all necessary information for reimbursement. In case of theft, I will be responsible for reimbursing Dura Cycles for the original price of the bicycle (s) plus the cost of any accessories that were provided at the time of the bicycle rental.

ASSUMPTION OF RISK, WAIVER AND RELEASE AGREEMENT

Assumption of risk: I understand and accept that renting this bicycle and participating in bicycling exposes me / my child to many hazards that may entail unavoidable risk of death, personal injury (including but not limited to severe spinal and head injury) and loss or damage to property. I also understand that I / my child should be in good physical health to participate in bicycling, and I confirm that I / my child have no medical conditions, nor have I / my child been diagnosed with a condition that prevents me from bicycling. In spite of the aforementioned risks and acknowledgements, I hereby assume all risk or injury or loss of life to myself / my child and loss of damage to property arising out of renting this bicycle and participating in bicycling. I understand the inherent risk involved in using this rental bicycling equipment and accept full responsibility for any and all such damage or injury which may result.

Waiver and Release: In consideration of Dura Cycles renting me / my child this bicycle, I specifically release and forever discharge Dura Cycles and its affiliates, officers, agents, and employees from any and all liability or claims for injury, illness, death or loss of damage to property which I / my child may suffer while renting this bicycle(s) and participating in bicycling. This discharge specifically includes, but is not limited to, liability or claims for injury, illness, death or damage caused by the negligence of Dura Cycles or its affiliates, officers, agents, or employees. It is my intent by Waiver and Release Agreement to release Dura Cycles and hold it harmless from all liability for any such property loss or damage, personal injury or loss of life, whether caused by the negligence of Dura Cycles or whether based upon breach of contract, breach of warranty, or any other legal theory. In signing this document, I fully recognize that if injury, illness, death or damage occurs to me / my child while I am engaged in renting this bicycle(s) or participating in bicycling, I will have no right to make a claim or file a lawsuit against Dura Cycles or its affiliates, officers, agents or employees, even if they or any of them negligently cause my injury / my child's injury, illness, death or damage.
